The committee approved the following course and program revision as amended.

1. The committee approved as revised the course addition for MFT 592: School-Based Family Counseling in the Marriage and Family Therapy Department (Anne Pautz, Representative). The revised course description is as follows.

MFT 592 MFT practice and intervention in public schools, school-based systems theory, learning theory, state and federal education laws pertaining to the health and education of children, and statutory requirements for mandated reporting, suspensions/expulsions, and school/district accountability; strategies for communicating and collaborating with families about students' progress; school-based ethics, and policies and procedures governing special and general ed. services for collaboration, referral, and placement.

2. The committee approved as revised the program revision titles for all three strands of the MASTER OF SCIENCE PROGRAM in the Special

Education Department (William R. Nelson, Representative). The revised program titles are as follows.

a. MASTER OF SCIENCE PROGRAM—

STRAND A: FOR STUDENTS NOT SEEKING CROSS ENDORSEMENT IN SPECIAL EDUCATION
WITH CERTIFICATION IN OTHER AREAS OF EDUCATION

b. MASTER OF SCIENCE PROGRAM—

STRAND B: FOR STUDENTS SEEKING CROSS ENDORSEMENT IN SPECIAL
EDUCATION

c. MASTER OF SCIENCE PROGRAM—

STRAND C: FOR STUDENTS ALREADY CERTIFIED IN SPECIAL EDUCATION
