11. Report of the CCSU Faculty Senate Ad Hoc Committee for General Education.

A survey of the members of the School of Engineering and Technology Subcommittee showed a unanimous decision to recommend that the Senate create an implementation committee to draw up a General Education proposal based upon the design in the Report of the CCSU Faculty Senate Ad Hoc Committee for General Education with specific modifications listed below.

1. The SET subcommittee suggests adding flexibility to the credits requirements for the Critical Inquiry Seminar. This would include adding a range of 3-4 credits and the possibility of creating a multi-semester approach to the seminar (two courses, two credits each).

2. The SET committee objects to assessing Foreign Language proficiency for students with three sequential years of one foreign language as described in item C, 1a of the Report of the CCSU Faculty Senate Ad Hoc Committee for General Education.
