The General Education Committee embarked on a discussion of the TAP framework. The major issues for the subcommittee were: first, the action by the Board of Regents to forestall faculty consideration of the proposal and the implications of that action for CCSU; second, the ability of the present and proposed general education program at CCSU to accommodate the TAP requirements; and third, the preference on the part of some social science faculty and departments to see the language in the Social Phenomena category revised to include language related to the scientific basis of all social sciences and/or to see the language in the Scientific Reasoning and Scientific Knowledge categories broadened in order to more accurately reflect the inclusion of some social science courses in those categories. The Committee discussed each of these issues at length.

The question was called by Karpuk/Prescott. The vote was 9-1 (Smith dissenting). The vote for ratification of the TAP requirements was 4-3 with 2 abstentions.
