7.1 EDF 215 Item was deferred to Full Committee by Gen. Ed. subcommittee over concerns that inclusion of study area 3 would impact other departments offering other SA3 courses. Discussed in depth, with concerns on one hand that proposal should be delayed to allow impacted departments to discuss in depth, vs. departments who need to incorporate change into planning for Fall curriculum

changes. Ed.L. representatives pointed out that change was *required* and BoR are putting pressure on them to adopt. Other three CSU's have already done so. Approved by hand count.
