*At the CLASS meeting on 10/19/16, this policy was discussed with the following changes recommended:

1. We remove line 1, which removes the lapsed expiration date. The policy will now be permanent.
2. Fix the formatting and numbering to reduce confusion.
3. Suggested that what counts as a credit hour in federal law be more clearly stated. Suggests changing CFR to Code of Federal Regulations. Suggests adding this language: “Note: The Code of Federal Regulations is available from the U.S. Government Publishing Office at www.gpo.gov, through the Federal Digital System. The credit hour is defined in Title 34 – Education, §600.2 Definitions.
