OCTOBER SENATE REPORT

The following Report to the Faculty Senate was approved at its October 20, 2003 meeting.

(Unless otherwise noted, course additions/changes/deletions take effect in Summer/Fall 2004; program changes/additions take effect for Spring 2004. *New wording for course and program changes is noted in italics.*)

1. Department of Music.

- a. [Program Revision](#) of Minor in Music.

18 credits in Music, as follows: Area I: 9 credits from MUS 109, 110, 111, 112, 115, 116, 121, 122, 221 Area II: 4-5 credits from MUS 114, 250, 251, 264, 350, 351, 363, 364, 380 Area III: 4-5 credits from MUS 140, 141, 142, 143, 177 (This will take effect retroactively, in Fall 2003).

2. Department of Technology Education.

- a. [Course Revision of TE 445](#) Construction Systems.

Change prerequisites to: TE 215 or TC 215 or permission of the instructor.

Change description to: Study of systems and technical means used to build structures, or constructed works, on a site. Designing, creating, testing, assessing impacts, and determining alternate means of building shelters and non-shelters. [G]

3. Department of Communication.

- a. [Course Addition of COMM 380](#), Women and Film.

Examines selected films with regard to the representation of women on screen, women's filmmaking as a critical practice, and issues in feminist film theory and criticism. Includes perspectives on Hollywood and independent American and international cinema. Fall (e). 3 credits.

- b. [Course Revision of COMM 336](#), Media Literacy.

Change prerequisite to: COMM 230 (C- or higher).

Delete special condition: Majors only.

5. Center for International Education.

- a. [Course Addition of IELP 500](#), Graduate Transition.

Prerequisite: Permission of IELP Director. Ten hours per week of integrated language skills for advanced ESL students planning to enroll in a CCSU graduate program. Focus on expository and argument writing, academic reading skills, focused discussion and formal debate. Additionally, the course will familiarize international students with American academic library resources and intellectual property issues. [G] 0 credits. (Effective Spring 2004).
