**UPBC** Minutes

Meeting March 26, 2008

Members in Attendance: Blitz, Bigley, Toston, Hosch, Valk, Martin, Talit, Crundwell, Lovitt

Item 1. Minutes from 2-6 and 2-12 meetings were approved

Item 2. Strategic Planning Grants are to be approved at the next meeting. Blitz suggested that the four initiatives were workplace effectiveness, community engagement, interdisciplinary studies, and international studies. Suggestions from the floor included student retention and graduation and the item was tabled to allow revision of the areas of initiative.

Item 3, The budget response was accepted with deletion of all references to the FYE budget. The amended response will be submitted to President Miller.

Item 4. VP Toston talked about the goals of co-rec activities on campus stating that facilities for recreation have already been outgrown and four sites for a fitness center are currently being evaluated. There is discussion about fees for guests to use our facilities as well as acknowledgement that student labor needs will rise as new facilities come on line. To facilitate discussions that will insure that new facilities are used for recreation needs the UPBC requested that the concnerned parties(recreation, academic, athletics) meet to discuss planned use of the facilities

Item 5. The report from the ad hoc committee on uniqueness was accepted and will be sent to the Senate with the appendix only available on line. The four elements of distinctiveness approved were international education, workforce and State economic development, community engagement, and cross-curricular initiatives.

Item 6. The inclusion of IT goals into the current goals list was tabled

#### **UPBC** Minutes

Minutes to March meeting approved with the following corrections – Pudlinski should be added to the members in attendance and <u>interdisciplinary studies</u> and <u>cross-curricular initiatives</u> should be in the list of identifiers.

Item 1. Themes for the Strategic Planning Grants were moved and accepted as Instructional Technology, Internal Climate, Workplace Preparartion, International Education, Enrollment Management, Student Success, Sustainability, and Interdisciplinary Programs.

Itme 2. Inclusion of IT into the goals list. A goal was added to explan technology-based resources and IT support to improve employer productivity. Also to insure faculty have the technology, support, and professional development to perform their work effectively.

Approval of new bullets to incorporate IT into goals with all new bullets at the end of each section passed unanimously.

The new goals as well as the uniqueness identifiers have been sent to the Senate.
