## Chair's Report from Academic Standards Committee

Presented here is the proposal that was considered and approved by the Academic Standards Committee at our April 26<sup>th</sup> meeting.

## COURSE WITHDRAWAL POLICY PROPOSAL

- 1. Add Drop week remains as is. Students may drop by the end of the 3<sup>rd</sup> week with no indication of this on their transcript.
- 2. During a student's time at the University, the student is limited to a total of <u>5 course</u> withdrawals. This does not include any semesters in which the student must withdraw from <u>all</u> courses due to extenuating circumstances (i.e., University Withdrawal/Leave of Absence).

[ITEM 2 IS DELETED, AS PER MOTION ON SENATE FLOOR MAY 9, 2011]

- 3. Students may withdraw from a course from the beginning of the  $4^{th}$  week of the semester until the end of the  $12^{th}$  week of classes by completing and submitting the Course Withdrawal Form at the Registrar's Office.
- 4. 4. A student seeking to withdraw after the 12<sup>th</sup> week of class and until the last day of classes must present documentation of extenuating circumstances for his or her request and submit a Withdrawal after Week 12 Form with the signatures of the instructor of the course and the chair of the department in which the course is taught. If the request is approved, the student will receive a grade of "W." Similar to the Course Withdrawal Form described above, the Withdrawal After Week 12 Form will advise students of possible ramifications of course withdrawal and will include the statements/sample language outlined above.
