

Economics: Professor Beth Merenstein (Sociology) will serve as a member of this DEC.

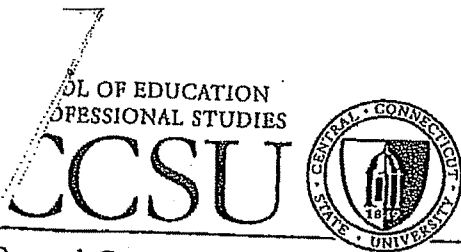
Marketing: Professor David Fearon (Management and Organization) and Dr. Harlan Shakun (Finance) will serve as members of this DEC.
