The Curriculum Sub-Committee met regularly throughout the year to discuss: 1) the d-

designation workshops; 2) encouraging more faculty to submit courses for d-designation

approval; 3) streamlining the steps for the process of approval; 4) encouraging more

faculty to use their d-designation courses for assessment.

A d-designation workshop was held on Oct 17 and 27, 2011. There were four faculty

members who participated. Faculty members were present from the departments of

Special Education, Modern Language, Dance, and Marketing. The workshop was a

productive experience focusing on the overall framework of the designation and

opportunities to make connections within the selected courses that professors

provided.

The sub-committee worked hard to streamline and make easier the process of applying

for a d-designation. The clearer and more concise guidelines are now on the FSDC

website and the University's Curriculum website.

The sub-committee continued to recruit interested faculty in either participating in the

d-designation workshops or in submitting courses to the ongoing d-designation list. As

of April 2012, there are 7 d-designation courses with an additional 5 coming though the

curriculum committee. Our goal is to achieve 25 d-designation courses by May 2013.
