## **Faculty Senate Constitutional Amendments**

## A) Replace article 3.4 with the following articles (new language in bold italics)

Proposal: Replace article 3.4 with the following 3.4.1 and 3.4.2

- 3.4.1 All of the following administrators shall be non-voting members of the Faculty Senate exofficio, without the power to make or second motions, to become President, Vice President or Secretary or serve as officers on any Standing Committee of the Senate or of the Faculty: the President of the University, the Vice President of Academic Affairs, the academic and graduate Deans or their chosen representatives.
- 3.4.2 Unless otherwise elected to serve as full members of the Senate, the following shall also be non-voting members of the Faculty Senate ex-officio, without the power to make or second motions: the President of CCSU-AAUP, the President of the CCSU chapter of SUOAF-AFSCME, and the CCSU representative to the Faculty Advisory Committee to the Board of Regents.
  - B) Modify Article 3.6.6 with the following articles (new language in bold italics)

Proposal: Renumber 3.6.6. as 3.6.6.1 and add 3.6.6.2 as follows:

- **3.6.6.1** No person can serve for more than two consecutive full terms as President of the Faculty Senate.
- 3.6.6.2 No person can serve for more than two consecutive full terms as Vice President of the Faculty Senate. (and renumber 3.6.6 as 3.6.6.1).
