- d. Updated Safety Flyer The current Safety Flyer, circulated with the agenda, was reviewed. The flyer is open for comment for one more week. After that it will be laminated and posted in all classrooms on campus. D. Blitz asked to see a link from the Senate website to the flyer and also to have the flyer produced in hardcopy form and distributed to all faculty and staff via campus internal mail.
- e. Faculty Handbook Update The Faculty Handbook now exists in draft form. Throughout the semester, F. Latour will be presenting chapters of the Handbook The Senate is asked to review the chapters and let him know if something needs to be changed, added or deleted. The following two chapters were presented at this meeting
 - i. Chapter 7 is about Renewal, Promotion, Tenure, and Professional Assessment. It includes AAUP contract language, a copy of the Promotion & Tenure Policy (also available on the Senate website) and a statement about Departmental Guidelines (also available on the Senate website).
